Modifications have been made in the pedagogy from the academic year 2018-19 i.e. Activity Based Learning – a new approach for classes I to III and Simplified Active Learning Methodology for classes IV and V. Modified G.O. no.200 dated: 26.9.18 for ABL and SALM has been issued. Hence it has to be implemented effectively in all schools.

Training was given for the teachers about this new approach along with the new book orientation training for class I at the block level in all districts. But BRTEs are not well versed in the new approach so they are unable to clarify the doubts raised by the teachers as well as unable to fill up the gaps in the process. Modified ABL training for BRTEs is inevitable as their major role is to monitor the classroom transaction of the elementary schools. So it is mandatory for the BRTEs to be aware of the modifications made in the primary pedagogy.

Hence one day training has been planned for the BRTEs at state level and at district level. At the district level, teachers (as in annexure) from the pilot study schools are included as a resource person to take model demo class along with the two BRTEs (KRPs). Since BEOs are the monitoring officials at the block level they can also participate at the district level training. All the district coordinators should also be the participant in the district level training so that they can ensure the effectiveness of the teaching – learning process during their school visit.

Hence one day training has been planned for the BEOs, Supervisor(i/C) and BRTEs, at District level
